## Library Director Kathy Glick-Weil to Begin Series

On September 10 the Unit Committee will be presenting the first meeting of the year. Designed to educate League members on timely topics, unit meetings are held monthly, usually in a member's home. The topic for September is the U.S.A P.A.T.R.I.O.T. Act. Our guest speaker will be Kathy Glick-Weil, Director of the Newton Free Library.

Special emphasis of this discussion will be on Section 215. Ms. Glick-Weil explains:

*"Section 215 of the USA Patriot Act grants unprecedented authority to the FBI and other law enforcement agencies to obtain search warrants for library records by claiming that the desired records may be related to an ongoing terrorism investigation. It also includes a gag order provision prohibiting any person or institution served with a search warrant from disclosing to anyone other than an attorney what has taken place. Probable cause is not required to invoke this section of the Act. Library records of what patrons borrow are considered private in Massachusetts and almost every other state, and this Act puts people at risk for exercising their free speech rights to read, recommend, or discuss a book. It also threatens their ability to write a private e-mail or participate in a chat room."*

Please join us to learn about this topic and to have the opportunity to become acquainted with the new Accu-Vote Optic Scan voting machines which will be in operation throughout Newton for the September 16 Preliminary Election.

I would like to thank Priscilla Leith for her willingness to be the topic coordinator for this meeting, Bonnie Carter for arranging to educate us on the new voting system, as well as Pat Acton, Rose Davis, and Bev Spencer for their invaluable contributions to the smooth functioning of the Unit Committee. # School Department Creates Environmental Management Program

The School Department has formed a District Environmental Management Team under the auspices of the Operations Department. The team has wide representation including: Custodial Union, Newton Teachers Association, Food Service, Career and Technical Education, Science and Fine Arts Departments, Health Department, Fire Department, Public Buildings, Department of Public Works, and Human Resources Department.

The Environmental Management Program is intended to deal with indoor air quality, chemical reduction and management, waste reduction and management, integrated pest management, and other environmental issues as needed. The stated goals of the program are to:

- Ensure a safe, healthy environment for students and staff
- Provide timely, effective systems for the school community to report and resolve concerns related to environmental issues such as: indoor air quality, integrated pest management, hazardous materials, and waste management.
- Involve departments and schools in development and implementation of the program.
- Provide resources and technical assistance to schools.
- Develop a long-term program to prevent environmental problems.

In the fall of 2003, each school will establish a school-based environmental team that will oversee and plan for environmental issues at the school location. Working with the district team, the school-based teams will: be trained to conduct investigations, prioritize findings and needs, develop recommendations for resources for training, supplies, and equipment; and develop long-term response and preparation plans for a variety of situations and issues. ■

This report encompasses the March, April, May and June 2003 meetings of the Commission and includes regular reports given at each meeting by Fran Towle, the Commissioner of the Parks and Recreation Department.

At the May meeting only four Commission members attended, so there was no quorum and no official business was conducted.

## Newton Parks and Recreation Department

### Skate Park Committee Update

The Skate Park Committee, chaired by Ward 6 Commissioner Walter Bernheimer, released its report on January 27 at the Park and Recreation Commission meeting. This was a comprehensive survey that found 3,000 to 4,000 potential users who live in Newton and asked the Mayor to make a determination whether to use public or private funds for a feasibility study. The motion stipulated that if private funds are used the study is to be under the control of the Newton Parks and Recreation Commission. The mayor responded urging the group to seek private donations for the study. Two proposals have been received, one from Camp, Dresser, McKee (\$13-14,000) and one from Marion Pressley Associates (\$21,000). The proposals are an effort to find out how much the Committee will need to raise to get on with the project. The potential sites are Cabot Playground, Newton Highlands Playground and Warren Playground. The Skate Park Committee chose the low bidder and is now discussing how to do the fundraising.

### Albemarle Playground Outdoor Community Classroom

In November, 2002, the Albemarle Playground Project Committee, a 501(c)(3) nonprofit organization, submitted a proposal to the Newton Community Preservation Committee requesting \$87,135 to create an outdoor classroom/park on the south portion of the Russell Halloran Sports and Recreation Complex along Albemarle Rd in Newtonville. It is adjacent to the tot lot behind Horace Mann School which was accidentally bulldozed by a city contractor last year and which the city has pledged to rebuild. The APPC proposal contains a gazebo, benches, a sundial and a weather station and is designed to serve disabled persons, children, and senior citizens. (There is an elderly housing complex nearby on Watertown St.) This proposal meets the need for more "passive recreation" in this area.

The proposal was referred to the Parks and Recreation because it contained the structure of the gazebo being placed on recreation land. At the April 28th meeting the Parks and Recreation Commission voted to approve the concept of the Albemarle Project subject to the completion of a blueprint for the Community Classroom itself that meets the specifications established by the 1993 policy – *Procedures for Alteration of Lands for Private Organizations on Recreation Lands*. Both items are on the agenda of the June 26 Conservation Commission meeting. Time factors may mean that neither project can be started until September, 2003.

There is some sentiment that a Master Plan for the entire Russell Halloran Recreation Complex should be completed before any project is built, including the Outdoor Community Classroom and perhaps reconstruction of the tot lot. No agreement was reached as to who will develop such a plan and how it will be paid for. The Commission will research the master plans of the parks and recreation lands of other cities/towns of comparable size and discuss it further in September.

Both projects also need to get the approval of the Conservation Commission due to the removal of earth and the proximity to the brook that runs along the east edge of the site.

### Other Business

- Millenium Park went out to bid in May, estimated cost being \$318,000. Completion expected in June, 2004.
- The Newton Recreation Department will have a website.
- Permit was granted for St. Mary of Carmen Carnival in July after much discussion of regulations governing it and how they will be enforced.
- New Assistant Superintendent of Maintenance Derek Mannion holds a degree in forestry, and has experience in horticulture and golf course maintenance.
- Docks for Crystal Lake went out for bid and may be in place by the end of the season.
- Fee increases ahead for Recreation Department Programs. These and other cost cutting measures will help raise \$50,000 more to balance the department budget.

### Follow Up

The following items came up and were approved at the July 14, 2003 meeting of the Board of Aldermen:

- \$30,000 appropriated from the Marathon receipts to purchase new playground equipment, replacing worn, defective or unsafe playground equipment throughout the city. It includes equipment for the Albemarle tot lot behind Horace Mann School.
- \$99,931 appropriated for costs of the Albemarle Community Classroom from CPA money. ■

The State House News Service provides comprehensive information and updates about events on Beacon Hill. Weekly advances provide a look at what's expected to make news in the week ahead and why. Daily schedules show what's slated for the governor, Legislature and agencies. Editor's advisories indicate what the News Service is covering that day and what's making news at the State House. The News Service produces gavel-to-gavel coverage of every action taken and every speech given on the floor of the House and Senate. Also included are press releases, weekly news recaps, feature stories, archives of news coverage back to 1986, and archives of press releases back to 1997.

It is available in the library only (look under "Magazine and Newspapers" and then click on "State House News Service").

Perhaps Newton League of Women Voters members would really be interested in consulting this service. Next time you are in the library take a look!

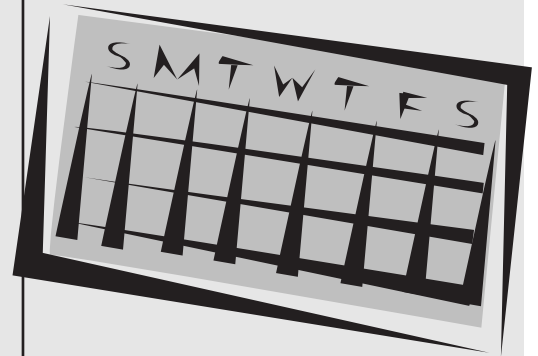
